## Training and Orientation of the Youth Peer Mentors

Once hired, the Youth Peer Support Specialists will be required to undergo several types of training and orientation. The Moving Forward training must occur prior to contact with consumers using the TIP model of case management. The State of Maine Certification for Intentional Peer Support training must be initiated within twelve months of hire. The trainings, parties responsible, duration and associated costs are outlined below.
